



**WORD DANCE THEATER LIABILITY & COVID-19 LIABILITY WAIVER**  
**January 2022**

I, on behalf of myself and/or my child, acknowledge the contagious nature of the Coronavirus/COVID-19 and that the Center for Disease Control (CDC) and many other public health authorities recommend practicing social distancing, face coverings, and frequent hand washing. I further acknowledge that Word Dance Theater has put in place preventative measures to reduce the spread of the Coronavirus/COVID-19 for indoor and outdoor meetings.

I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to staff, students and their families. I further acknowledge that Word Dance Theater cannot guarantee that I will not become infected with the Coronavirus/COVID-19.

I voluntarily attend classes with Word Dance Theater and acknowledge that I am increasing my risk of exposure to the coronavirus/COVID-19 by entering into a new space. To reduce my risk of exposure to the virus, I have read through the [CDC guidelines here](#).

I acknowledge that I must comply with all set procedures to reduce the spread while attending classes with Word Dance Theater.

I attest that:

- I/My child are not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I/My child have not traveled internationally within the last 14 days.
- To the best of my knowledge I/my child have not been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19 in the last 5 days.
- I/My child have not been diagnosed with the Coronavirus/COVID-19 in the last 5 days.
- I/My are following all Word Dance Theater recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

Student agrees to abide by all class safety requirements relating to Covid 19 safety procedures:

- Keep a distance of 3 feet or more when participating from all other attendees and instructors while in class, and wear a facemask.
- Enter and leave in the assigned areas from the class.

- To not attend class if having come into contact with anyone that has tested positive in any COVID-19 tests in the last 5 days.
- Not to share any equipment, water bottles and any other objects that I have come into contact with while attending class.
- Remove all personal property and belongings upon leaving the property at the conclusion of class.

I, on behalf of myself and/or my child, hereby release and agree to hold Word Dance Theater harmless from, and waive on behalf of myself, my heirs, and my personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act by Word Dance Theater, or that may otherwise arise in any way in connection with any services received from Word Dance Theater. I have chosen to participate in dance instruction given by Word Dance Theater. I acknowledge that I understand the nature of the activities that I will be participating in and that I am in the proper physical condition, and capable of participating in the related activities, understanding that Word Dance Theater and it's instructors are not in any way responsible for making such a determination.

I understand that this release discharges Word Dance Theater from any liability or claim that I, my heirs or any personal representatives may have against Word Dance Theater with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to any services received from Word Dance Theater.

This liability waiver and release extends to Word Dance Theater together with all employees, staff, or volunteers.
